4a) In pursuance order of the Finance Department, GoWB vide no- 4608-F(Y) dated 18.07.2018, the bidder shall be liable for submission of Bank Guarantee to the tune of 10% of the tendered amount in addition to the normal Security deposit of 0% in the event of the submitted financial bid being more or equal to 20% less.

The subsequent issuance of Work order shall be processed after submission of the Bank Guarantee, which shall be valid till the date of completion of contract and shall be subsequently refunded successful completion of the execution.
