6) The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of **3 (Three) year** from the date of successful completion of the work to the entire satisfaction of the Authority. If any defect / damage are found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deemed fit. The contractor may quote his rate considering the above aspect. Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned above for **3 (Three) year** from the date of completion of the work. Terms and Conditions of Chandernagore Municipal Corporation shall be treated as superseded. **Vide Order No- 592/1(125)/MA/10/3S-21/2013 dt. 28 day of October 2016.**

7) Site of work and necessary drawings may be handed over to the agency phase wise. No claim in this regard will be entertained.

8) **Earnest Money 2% of the estimated amount put to tender. It is to be submitted online. Tender fee, which is non-refundable, is to be submitted online**

9) The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.

10) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The tender accepting authority of Chandernagore Municipal Corporation reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by an Tenderer at the stage of Bidding.
